1. はじめに

1.1 本調査の背景と目的

日本には数多くの開発コンサルティング企業があるが、アジア開発銀行（以下、ADB）など国際機関への取り組みはそれほど強くない。例えば、ADB が 2014 年から 2018 年に実施した Technical Assistance（TA）で、日本企業が単独あるいは Joint Venture のリードとなった場合の落札数は表 1.1 に示す通り計 36 件であり、国別では全体の 8 位（全体の 4%）に過ぎない。

ADB 内部でも日本企業による受注の増大の必要性が指摘されているとのことである。ADB の実施する TA プロジェクトを落札するには日本企業単独では難しく、落札率を高めていくには、アジアのコンサルティング企業と連携して応札することが効果的であると考えられる。

本自主研究調査では、こうした課題に対処するため、アジアのいくつかの開発コンサルティング企業の概要を把握することを目的とした。具体的には ADB からの受注実績のある企業を中心に選定のうえ、ホームページなどで情報収集し、そのうえで実際にコンサルティング企業と面談し、情報を取りまとめた。また、ADB の分野別の受注コンサルティング企業を巻末に参考資料としてとりまとめた。

1.2 本調査の実施体制

本調査は一般財団法人国際開発センターが株式会社国際開発センターに委託して実施した。調査実施者および訪問国は以下のとおりである。

2. 開発コンサルティング企業

2.1 Mediconsult²

Mediconsult は 1993 年に設立されたコンサルティング企業であり、その名の通り保健・医療分野を主たる活動領域としている。マレーシア国内のみならず、ベトナム、中国、インド、インドネシア、ネパール、パキスタンなどのアジア諸国、ケニア、マラウイなどのアフリカで実績を有している。

保健・医療関係に特化しているが、とりわけ以下の分野においてコンサルティング・サービスを提供している。

2.2 PE Research³

PE Research は現代表の Chang Yii Tan 氏が 1991 年に設立したマレーシア・クアラルンプールを本拠地とするコンサルティング企業である。政策・計画、社会経済、環境、プロジェクト形成・評価など経済社会分野が主たる業務領域であり、マレーシアの官公庁（国、州）などからの受託が中心となっている。また、JICA や DANIDA など二国間援助機関からの再委託業務を受注した経験なども有している。主たる分野は以下のとおりである
